Message from the President, Dr. Krishan Lal

As the newly elected President of CODATA I welcome the opportunity to share with you some of my thoughts and aspirations for CODATA as we start 2007.

We all are experiencing an unprecedented rate of advancement in science and technology as well as in their applications for wider usage by common man. Scientific data have been one of the key components that have propelled the growth of science and technology. The International Council for Science (ICSU), realizing its vital importance, established in 1966 a multi-disciplinary Committee on Data for Science and Technology (CODATA). Recent spectacular achievements in information technology have changed the way scientific research is being carried out. Similarly, modes of storage, dissemination, archiving and management of data have undergone much change. It is now possible to network with research groups located anywhere in the world through internet and to transfer huge amount of data and other information practically without loss of time. It is hoped that the possibility of networking of a large number of research groups together with possibilities of grid computing and other recent developments will be instrumental in taking science to new heights. Technological developments are expected to transform human society.

CODATA has been actively involved in communicating the aspirations and viewpoint of the scientific community as a stakeholder to the recently held UN sponsored World Summit on Information Society. A new initiative on Global Information Commons for Science has been launched by CODATA and its collaborating partners. CODATA aspires to reach out to scientists in all regions of the world, particularly in regions that have not gained adequately from international cooperation. We are deeply concerned about lack of infrastructure in most of the developing world, which is hampering their efforts to take full benefit of the IT revolution, particularly for the applications of internet in improving education, health, environmental protection and efficiency of administration. It has taken initiatives to help bridge the digital divide.

Also, CODATA is working on new schemes for young and budding scientists all over the world. The 2006 CODATA Prize has been awarded to Dr. John Rumble, Technical Director for Information International Associates. Rumble received the prize in Beijing, China, on 22 October 2006. The prize is awarded biennially for outstanding achievement in scientific and technical data.



Rumble, former Director of the Standard Reference Data Program at the National Institute of Standards and Technology (NIST), was honored for being “an innovator in the world of scientific and technical data.” He has been instrumental in extending data evaluation techniques in new disciplines, including engineering, materials, and biotechnology. Rumble has long been a leader in using advanced information technology for developing computerized databases, online data networks, and data exchange standards. The 20th International CODATA conference, “**Scientific Data and Knowledge within the Information Society**,” took place in Beijing on 22-25 October 2006. It was without a doubt the most successful and largest conference in CODATA’s 40 year history. It attracted more than 600 participants from approximately 30 countries.

Also running through the programme was a sense of CODATA's evaluation of its own purpose, reflected in a retrospective view of its past 40 years of existence, and a session looking to its future directions.

CODATA Takes the Lead on GEO Data Management Task DA-06-01

“Furthering the Practical Application of the Agreed GEOSS Data Sharing Principles”

The Group on Earth Observations has agreed on a strong set of data sharing principles for the planned Global Earth Observing System of Systems (GEOSS):

- *There will be full and open exchange of data, metadata, and products shared within GEOSS, while recognizing relevant international instruments and national policies and legislation.*
- *All shared data, metadata, and products will be made available with minimum time delay and at minimum cost.*
- *All shared data, metadata, and products free of charge or no more than cost of reproduction will be encouraged for research and education.*

Implementation of the principles is a key issue for GEOSS as recognized by 2006 Work Plan task DA-06-01, “**Furthering the practical application of the agreed GEOSS data sharing principles.**” CODATA has agreed to lead this task and to this end it organized an experts meeting in conjunction with its 20th International CODATA Conference in Beijing on 22 October 2006. The meeting included more than 35 data experts from around the world. The meeting aimed to identify challenges to further application of the principles, options for addressing these challenges, and possible next steps for this GEO task.

This task is one of the continuing tasks identified in the GEO Work Plan for 2007-2009. CODATA looks forward to working with the GEO Secretariat and all interested stakeholders in the implementation of the Task over the coming years. □

The CODATA Hydrate Database Submitted by E. Dendy Sloan and Tom Smith

The objective of the CODATA Hydrate Database Task Group is to develop an internationally distributed database for Natural Gas Hydrates, which represent an energy resource equal to twice that of the total of all the other hydrocarbon resources. The knowledge base in this area is exploding with publications that more than double each decade.

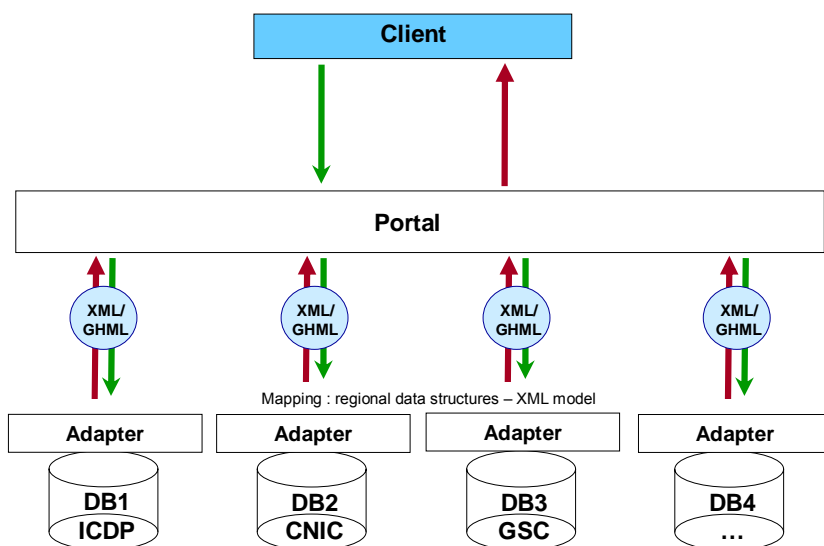
The CODATA international database is an efficient approach for dealing with the data and knowledge overload. With a number of hydrate databases being developed (e.g., by China, Canada, ICDP, and the USA), our goal is to connect these databases with a

specially developed Gas Hydrate Markup Language (GHML) and a Portal (to be developed in 2007) to allow free canvassing of these databases by any user.

When in effect (early 2008) the CODATA Hydrate Database will work according to the concept shown in the figure below. The concept rests on the establishment of the databases which contain the needed information (the DBs at the bottom of the diagram), labeled ICDP (for InterContinental Drilling Program), CNIC (for the Chinese Computer Network Information Center), GSC (for the Geological Survey of Canada), etc. Without the foundation of these underlying databases, there would be no need for linking the communications.

At the top of the figure is a Client who may request some information about hydrates. This client query is sent to a Portal, which communicates with the various databases through a common language – the Gas Hydrate Markup Language (GHML). Thus, the client’s query and response are communicated with each participating database, so that a number of data responses are obtained.

By 1 February 2007, the CODATA Hydrate Database Task Group expects to put the GHML on the CODATA website (www.codata.org) for comment by the CODATA and Hydrate community during the first six months of 2007. Please provide your critique through the online suggestions posted at CODATA.org. □
